AFFIDAVIT

David John Herbert Watt of Level 18, 255 Adelaide Street, Brisbane in the State of Queensland, Solicitor states on oath:

- 1. I am a partner of Flower & Hart, solicitors for the applicant and I have the conduct of this action on behalf of the applicant.
- 2. The respondent, Anthony John Hunter Morris QC was appointed as a commissioner under the Commissions of Inquiry Act 1950 by Order in Council made on 26 April 2005. The respondents, Sir Llewellyn Edwards AC and Ms Margaret Vider were appointed Deputy Commissioners pursuant to the said Act by the Commissioner on 28 April 2005. Exhibit DJHW1 is a true copy of the Order made 26 April 2005 and appointment dated 28 April 2005.
- 3. The applicant was and is the Director of Medical Services at the Bundaberg Base Hospital, having commenced in that position on 14 April 2003, following an appointment made on 21 January 2003.
- 4. The Director of Medical Services position has a job description which varied from time to time, but in general terms the duties and lines of reporting, I am instructed, are reflected in the position description exhibited to the affidavit of the applicant to be filed herein.
- 5. The Director of Medical Services reported to the District Manager. The heads of the various medical departments, including the head of surgery (Dr Patel) and the head of medicine (Dr Miach) reported to the Director of Medical Services.

- The Director of Nursing reported to the District Manager and the nurse unit managers 6. (including Toni Hoffman for the Intensive Care Unit) reported to the Director of Nursing.
- In issue at the Inquiry has been the extent of the complaints made to, and therefore the knowledge of the applicant concerning the clinical conduct of Dr Patel, and the appropriateness of the applicant's response to that conduct.
- 8. Central to that has been a claim that Dr Miach gave to the applicant in or about May 2004 a document being exhibit 18 before the Inquiry described as a peritoneal dialysis catheter placements audit. Exhibit DJHW2 is a true copy of that document.
- 9. An earlier version of that document was created at some time and became exhibit 69. Exhibit DJHW3 is a true copy of it.
- 10. The timing of the versions of the documents and their provision to the applicant remains in issue.
- On the hearing of this application the applicant intends to have tendered a copy of the 11. transcript of the proceedings to date. It is not exhibited hereto because of its size. I refer below to a number of references in the transcript to be relied upon by the applicant, which list is not exhaustive, but is intended to assist in identifying the nature of the complaint of the applicant and the major points.
- The proceedings have been filmed by various television stations. It is intended that the film will be subpoenaed with a view to playing selected parts to the court to demonstrate, in a way the transcript does not always do, the differential treatment of witnesses before the inquiry.
- It is also intended that copies of exhibits 4 and 21, being statements of Ms Hoffman and Dr Miach, will be put before the court. They are not exhibited hereto because of their size.
- On the afternoon of the 4th day of sittings the applicant was summoned by the Commissioner to give evidence on about five minutes notice. No objection was taken to that course, even if it could be, because to do so would appear to be uncooperative with the Commission.
- 15. Under the Commissions of Inquiry Act 1950 the Commission has powers to obtain information from persons such as the applicant by other means and those powers were exercised during a break in sittings following the initial two week sittings. Exhibit DJHW4 is a true copy of a letter from the Commission dated 7 June 2005 enclosing a summons to the applicant. The summons was complied with. In that context the reason for causing the applicant to give evidence in Brisbane at the time is not apparent to me.

- The questioning of the applicant on day 4 was carried out entirely by the Commissioner and not counsel assisting. It did not appear as if counsel assisting had any role to play in the decision to call the witness or what he would be asked. The questioning carried with it a sarcastic and cynical tone, and was aggressive, though not so much as the questioning of Mr Leck which immediately preceded this process. It otherwise stood out in contradistinction to the questioning of other witnesses.
 - On 10 June 2005 the commission published an interim report. In it certain findings were made concerning issues of improper patient care by Dr Patel during the applicant's time as Director of Medical Services, including a recommendation there be a murder charge brought against Dr Patel. No notice of the intention to make such a report, or an opportunity to make submissions was provided to the applicant. The report was made following the evidence in chief only of the witnesses relied upon by the Commissioner, being Ms Hoffman and Dr Miach. Exhibit **DJHW5** is a true copy of the interim report.
 - 18. The cross examination of Mr Leck is from pages 355 to 371. The cross examination of the applicant commences at page 391. Following this cross examination there were some submissions made by counsel at pages 866 to 871. Reference is made in particular to page 869.40. Reference is then made to the cross examination of Dr Miach on 29 June 2005 at pages 1595 to 1653. Particular reference is made to 1638.35. Attention is also drawn to pages 1595 to 1601, and 1673 to 1680.
 - 19. The context and the significance of the matters sought to be explored appears from pages 1137 to 1138, where the Commissioner particularised matters the applicant should address.
 - Reference will be made to selected examples in the evidence of a number of witnesses, including Dr Miach and Ms Hoffman where leading questions are asked by the Commissioner and comments are made suggestive of a pre-disposition.
 - 21. The applicant makes the application on the basis that the matters referred to give rise to a reasonable apprehension of bias on the grounds of pre-judgment and differential treatment of witnesses.
 - 22. I am aware from statements made during the conduct of the Commission of Inquiry by the Commissioner and Counsel assisting the Commission that the issue of complaints made to the applicant concerning Dr Patel and the applicant's response to those complaints is the subject of an investigation by the Crime and Misconduct Commission. Counsel for the Medical Board of Queensland has advised the Inquiry that the Board is conducting its own investigations concerning matters involving Dr Patel. On 26 April 2005 the Premier of Queensland announced that an independent review of Queensland Health's systems is being conducted by Mr Peter Forster. Various media reports in recent times have indicated that Queensland Police are conducting their own investigations of Dr Patel's actions.
