EARLY APRIL, 2005

H.R.C. SUE MCANANEY RANG ASKED IF I HAD RECEIVED A REPLY YET FROM KEATING. SHE THEN RANG DR KEATING TO ENQUIRE. SHE THEN RANG ME BACK & ASKED IF I COULD WAIT ANOTHER 3 WKS FOR KEATING TO REPLY TO ME, AS HE WAS SO BUSY & HADNT INVESTIGATED GULLY. THEN IF I WASNT HAPPY WITH HIS REPLY I COULD THEN FORWARD THIS & ANOTHER COMPLAINT ONTO HER OFFICE & THEY COULD THEN INVESTIGATE. I ASKED IF I WOULD HAVE SOME PROTECTION FROM DR PATEL IN THE 3WK PERIOD, WOULD I BE EXEMPT FROM HAVING HIM, IF I NEEDED HOSPITAL.
