STATEMENT OF John Hugh BETHELL

I John Hugh BETHELL of Wavelength Consulting Pty Ltd Level 1, 257a Oxford Street Paddington Sydney in the State of New South Wales SWORN:

- 1. I am a Director of the Company Wavelength Consulting Pty Ltd which is company duly incorporated in the State of New South Wales with its registered office and its principal place of business located at Level 1, 257a Oxford Street Paddington Sydney New South Wales. I am a person duly authorised to act for and on behalf of that company. I have been a Director of this company for five (5) years. I am a duly qualified medical practitioner at present on the non-practising register in New South Wales.
- 2. Wavelength Consulting Pty Ltd is a medical recruitment firm specialising in the recruitment of doctors for placement throughout New Zealand, Australia and the United Kingdom. We have clients in each of those countries and as a result of previous dealings that we have had with those clients they will from time to time make contact with us seeking a doctor to work with them.
- One such client is the Bundaberg Base Hospital (the Hospital) located at Bundaberg Queensland. The person that we dealt with from that client was the Director of Medical Services, Doctor Kees NYDAM.
- 4. On 14 November 2002 we received a verbal request from Doctor Nydam to find and refer a surgeon that we may have available for the position of Senior Medical Officer at the Hospital.
- 5. As a result of this request I created a Job Order on our data base and then typically we would respond to that request by notifying our candidates that fit the criteria about the position. I do not now recall if I sent an advertisement for that particular role.

- 6. What occurred in this instance was that we were contacted by a Doctor Jayant PATEL via our website in a generic application format not setting out any specific location but telling us that he had a general interest in working in Australia as a General Surgeon.
- 7. He was initially reviewed by a colleague of mine within the company and he was then referred to me. On being made aware of his application I reviewed his application and called him to conduct a verbal interview to find out more about his clinical background and his interest in working in Australia.
- 8. At this time he was located in Oregon USA. I had a telephone conversation with him and informed him of the position in Bundaberg. On 13 December 2002 I sent him some generic information on about Bundaberg and the Hospital via e-mail.
- 9. He expressed interest in the role and on the same day we received from him his full CV. I sent the CV to the Hospital and Dr. Nydam later informed me via e-mail that he was interested in Dr. Patel. I then arranged for Dr. Patel and Dr. Nydam to speak with each other as part of the interview process.
- 10. At some stage between 13 20 December 2002 they spoke with each other. Dr. Nydam advised me on the 20 December 2002 that the Hospital wished to offer Dr. Patel a one year contract. Prior to 20 December 2002 I had received from Dr. Patel directly six (6) open references relating to his work in Oregon USA over the previous ten (10) years.
- 11. On 20 December 2002 I received an e-mail from Dr. Nydam giving me permission to make an offer to Dr. Patel of the position at the Hospital.
- 12. On 20 December 2002 I made personal contact with two (2) of them via telephone and they were Dr. Peter FELDMAN and Dr. Bharwar SINGH. They both confirmed the content of their references and responded very favourably to my specific questions about his clinical and interpersonal skills and character. Though I do not now recall the discussion, as it is my normal practice do so I believe that I then discussed the contents of the references with Dr. Nydam.
- 13. On 24 December 2002 I received a copy of the Appointment Letter from the Hospital for Dr. Patel. I passed that on to Dr. Patel.
- 14. On 29 December 2002 Dr. Patel sent me an e-mail confirming his acceptance of the position. I informed Dr. Nydam of Dr. Patel's acceptance.

- 15. On 06 January 2005 Dr. Patel completed an Application for Registration with the Queensland Medical Board (QMB). He forwarded that document to our office.
- 16. We also received from Dr. Patel various certified copies or original documents in support of his application as required by the QMB. These were: Passport page with photo; 2 passport sized photos certified as true likeness; Oregon Medical Licence; Current Certificate of Registration with Oregon Medical Board; Master of Surgery Certificate from Saurashtra University (India); Medical Degree from the same University; American Board of Surgery Certificate; University of Rochester Certificate of Completion of Residency Training; University of New York Buffalo Certificate of Completion of Residency Training; and Controlled Substance Registration Certificate US Justice Department.
- 17. On receipt of the copies of those documents we then forwarded them to the QMB. The QMB uses these documents to verify the credentials of the applicant doctor. On 19 January 2003, Dr. Patel faxed to us the Oregon Verification of Licensure without any attachment. He subsequently sent us the original of this document, again without the attachment. We then sent the original document to the QMB.
- 18. We followed our usual verification procedures in that we conducted the two (2) verbal reference checks in depth referred to previously and by obtaining all the verification documents as required by the QMB.
- 19. The QMB then issued us with a letter approving the doctor for Special Purpose Registration as a Senior Medical Officer on 12 February 2003. We included this document, along with The Form 55 signed by the Hospital, in an application to the Immigration Department for the issue of a temporary work visa (Class 422) for Dr. Patel. The Hospital was the formal sponsor and signatory on the visa application. Dr. Patel was required to lodge his own application for the temporary work visa in Washington DC.
- 20. He was subsequently granted the visa. He made his own arrangements to travel to Australia.
- 21. I understand that he then formalised his arrangements and registration by attending the QMB for an interview. He took up the position at Bundaberg. That completed our professional involvement with the placement. However, we did make some courtesy follow up calls at one and three month durations after his commencement.

- 22. The Hospital gave us very positive feedback at both time periods. The written feedback form dated 28 April 2003 returned to us by the Hospital rated Dr. Patel as "excellent" for quality of candidate.
- 23. In the appointment of Dr. Patel the Hospital was our client.
- 24. With regard to the pay rates of Overseas Trained Doctors (OTD's) all payment details can be found in the Medical Payment Awards issued by each State and Territory Government. For Medical Practitioners there is a separate Medical Practitioner's Award in each State. There is some latitude in terms of packaging in the first year at least (this applies to the first year of appointment because of relocation expenses etc and not their first year as a doctor). There can also be quite a big difference depending on the contractual arrangement and the amount of private practice that can be done (or is compensated for). This applies mainly to senior level specialists.
- 25. There are many other medical recruitment agencies throughout Australia and elsewhere who source medical practitioners for appointment at locations throughout Australia. I can provide a list of those agencies that we are aware of that tend to source medical practitioners for appointment in Queensland.
- 26. There is an agency called AMAQ Services which provides a range of services to its members including recruitment. It appears to have links with the AMA but I do not have any personal knowledge of the nature of these links.
- 27. The concept of "mutually recognised" doctors from other countries does not really have any meaning in our industry because, except for New Zealand, no qualifications have mutual recognition. Further the Royal Australian College of General Practitioner gives some recognition to the qualifications of the Royal College of General Practitioners in the United Kingdom.
- 28. All medical practitioner applicants who apply to work in this country must be assessed by a State Medical Board and possibly by the Australian Medical Council and a Specialist College if appropriate. They are then granted the right to work in Australia with varying levels of restriction (as dictated by the Board or College). In the case of Dr. Patel, it was the QMB which registered him to practise as a Senior Medical Officer.

- 29. In my experience doctors are recruited for positions similar to the one filled on this occasion in Bundaberg from countries other than Australia and New Zealand because no Australian or New Zealand applicants apply for such positions.
- 30. The fees that our company charge our clients with regard to this type of appointment are based on 15% of the first year salary package of the appointee. No further fees are charged by us if the doctor extends his contract with the employing hospital.
- 31. When we refer a medical practitioner candidate to be appointed to a position within Australia from overseas the employer is responsible for immigration/sponsorship issues. The employer is therefore the signatory on the documentation. Currently both the employer sponsorship application and candidate visa application are lodged in Australia. Our company assists in providing the hospital and the candidate with the relevant documents. It also maintains contact with the State Immigration Departments once the paperwork is lodged to ensure that there are no delays in the processing.
- 32. At the time Dr. Patel came to Australia there was a slight difference to this procedure. The sponsorship application was lodged in Australia by the Hospital and the candidate, Dr. Patel, lodged his application in the USA.
- 33. The immigration of the applicant requires a sponsor and confirmation of employment for it to be valid. The 422 Medical Practitioner Visa Class is specific for Doctors. The immigration of the applicant is fully dependent on his being appointed as a Medical Practitioner in this country.
- 34. The fee we receive for identifying and placing a candidate with a client is based on delivery of the candidate into the position applied for. If for some reason the candidate does not take up the position we refund all monies collected from the client to the client and no further invoices are issued by us.
- 35. Neither the faxed nor original Verification of Licensure provided to us by Dr. Patel at the time of his application had an attachment.
- 36. The Verification of Licensure provided to us by Dr. Patel refers to an attachment which reads "Public Order on File. See Attached." At the time of receipt of the document this did not appear to be significant, particularly in circumstances where the document stated that there were no limitations to his right to practice in Oregon.

- 37. The Verification of Licensure is the closest equivalent the Oregon Board of Medical Examiners has to the Certificate of Good Standing (CoGS). In Australia, New Zealand and the UK the CoGS is issued or it is not, there is no need to look behind it. Our company was not aware that the Verification of Licensure could be issued with conditions attached. In other words, our understanding at the time was that if such a document was issued it implied that the doctor was, by definition, in "Good Standing".
- 38. I have on this date handed to the Investigator from the Commission of Inquiry a copy of all the documents that I have referred to within paragraphs 9, 10, 16, 17 and 22.
